

Community Health Council of Wyandotte County Values Privacy

Your privacy is important to us. Together with our global Data Protection/Privacy Policy, this Online Privacy Policy explains how Community Health Council of Wyandotte County or its affiliate that displays this policy (“Community Health Council of Wyandotte County,” “we,” “us,” and “our”) protects your privacy when you visit this website and the websites of Community Health Council of Wyandotte County affiliates that display this Online Privacy Policy. This policy applies to “Personal Information”, information that identifies you personally, either alone or in combination with other information available to us.

Please take a few minutes to review this Online Privacy Policy. By accessing or using this Site, you are consenting to the collection, use and disclosure of your Personal Information as set forth in this Online Privacy Policy. Please also take a few minutes to review the Terms of Use section of our website. If you do not consent to the collection, use and disclosure of your personal information as set forth in this privacy policy or the Terms of Use, please exit and do not use this website.

This Online Privacy Policy describes what types of information we gather and track when you use our websites, how this information is used and with whom it is shared. If you have any questions about this Online Privacy Policy, please contact us.

What Information We Collect

If permitted by applicable law, we may collect the following information:

Information You Provide. We collect the personal information you knowingly provide by completing an online form, registering for information or services, applying for a job, or otherwise sending to us. For example, if you sign up to receive e-mail communications from one of our businesses, we collect your e-mail address and any related information you provide. If you communicate with us using the “Contact Us” feature, we collect the information you provide when you complete the “Contact Us” form.

Supplemental Information. From time to time, we may supplement the information you give us with information from other sources, such as information validating your address, information based on your zip code or business, or information that we have based upon your relationship with Community Health Council of Wyandotte County. For example, if you are a Community Health Council of Wyandotte County customer or supplier, we may supplement the information you provide online with information you provide through your business relationship with Community Health Council of Wyandotte County

Information Sent to Us by Your Web Browser. We collect information that is sent to us automatically by your web browser. This information typically includes your Internet Protocol (IP) address, the identity of your internet service provider, the name and version of your operating system and

browser, the date and time of your visit, the page that linked you to Community Health Council of Wyandotte County , and the pages you visit.

Cookies and Other Technologies. Community Health Council of Wyandotte County may use “cookie” technology on this website. A cookie contains information that is sent by a website and stored in your hard drive or temporary memory. You may change your cookie settings on your internet browser or delete our cookies at any time. We may use cookies to save your preferences for our websites or to collect statistics related to the number of visitors to our websites and requests for files, the types of browsers used, and other aggregate data. Community Health Council of Wyandotte County may also use transparent GIF files to help manage online advertising by collecting information related to which advertisements drive traffic to our websites.

Google Analytics. This website uses Google Analytics, a web analytics service provided by Google, Inc. (“Google”). Google Analytics uses “cookies”, which are text files placed on your computer, to help the website analyze how users use the site. The information generated by the cookie about your use of the website (including your IP address) will be transmitted to and stored by Google on servers in the United States. Google will use this information for the purpose of evaluating your use of the website, compiling reports on website activity for website operators and providing other services relating to website activity and internet usage. Google may also transfer this information to third parties where required to do so by law, or where such third parties process the information on Google’s behalf. Google will not associate your IP address with any other data held by Google. You may refuse the use of cookies by selecting the appropriate settings on your browser, however please note that if you do this you may not be able to use the full functionality of this website. By using this website, you consent to the processing of data about you by Google in the manner and for the purposes set out above.

Google AdWords. This website uses the Google AdWords remarketing service and possibly other services to advertise on third party websites (including Google) to previous visitors to our site. It could mean that we advertise to previous visitors who haven’t completed a task on our site, for example using the contact form to make an enquiry or to previous visitors who have viewed information on our products. This could be in the form of an advertisement on the Google search results page, or a site in the Google Display Network. Third-party vendors, including Google, use cookies to serve ads based on someone’s past visits to the Community Health Council of Wyandotte County website. Of course, any data collected will be used in accordance with our own privacy policy and Google’s privacy policy.

You can set preferences for how Google advertises to you using the Google Ad Preferences page , and if you want to you can opt out of interest-based advertising entirely by cookie settings or permanently using a browser plugin .

How We May Use and Share Your Personal Information

If permitted by applicable law, we may use the personal information we collect through our website:

- to provide products, information and services you request;
- to provide you with effective customer service;
- to improve the content, functionality, performance and usability of our website;
- to improve our marketing and promotional efforts;
- to provide technical support and troubleshooting; and
- for security, credit or fraud prevention purposes;
- for any other purpose identified in an applicable privacy statement or other agreement you have with Community Health Council of Wyandotte County .

If permitted by applicable law, we may share your information as described below:

- *Within Community Health Council of Wyandotte County* . We may share your personal information with Community Health Council of Wyandotte County affiliates for the purposes set forth in this Online Privacy Policy.
- *Our Service Providers*. We may share your personal information with companies or organizations, including subsidiaries, affiliates, and other entities that perform services on our behalf, such as website support service providers. In each case, such third parties are required to use adequate privacy protections and may use the information only for the purpose of providing services to Community Health Council of Wyandotte County .
- *Business Transactions and Transfers*. Community Health Council of Wyandotte County may buy, sell, form, or otherwise reorganize one or more of its businesses or sell stock or assets, for example, as the result of a sale, merger, reorganization or liquidation. A transaction of this type may involve the disclosure of your information to prospective purchasers or partners who have signed a confidentiality agreement with Community Health Council of Wyandotte County .
- *Compliance with Laws and Protection of Our Rights and the Rights of Others*. We may disclose personal information when we, in good faith, believe disclosure is appropriate to comply with the law, a court order or a subpoena. We may also disclose personal information to cooperate with a government investigation; to prevent or investigate a possible crime, such as fraud or identity theft; to enforce or apply our online terms of use or other agreements; or to protect our own rights or property or the rights, property or safety of our users or others.

We will not use your personal information to send product or promotional advertising unless you have agreed to receive product or promotional advertising. Other than the purposes described above, Community Health Council of Wyandotte County does not provide or sell your personal information to third-parties.

Location of Information

Community Health Council of Wyandotte County is a global organization with its corporate headquarters in the United States. Our servers, databases, and service providers are located in the United States and in other countries. Different countries have different privacy laws and requirements, and some, including the United States, may provide less legal protection for your personal information than others. By using this site, you are consenting to the collection, use and transfer of your personal information in or to the United States or other countries for the purposes described in this Online Privacy Policy.

Use of Special Features or Areas of Our Website

Some of our websites include special features, such as surveys, licensed content; or an online store; or password protected areas, such as a customers-only area or a careers area. This Online Privacy Policy may be supplemented or amended from time to time by privacy statements that are specific to and appear on individual Community Health Council of Wyandotte County websites, including but not limited to our investor and career sites. Generally, these statements provide details about the personal information we collect or do not collect on particular pages or areas of a website, why we need that information, and choices you may have about the use of that information.

When you sign up to use a special feature or password-protected area, you may be asked to agree to special terms governing your use of the special feature or password-protected area. In such cases, you will be asked to expressly consent to the special terms, for example, by checking a box or clicking on a button marked "I agree." This type of agreement is known as a "click-through" agreement. If any of the terms of a click-through agreement or another agreement between you and Community Health Council of Wyandotte County are different than the terms of this Online Privacy Policy, the terms of that agreement will govern over this Online Privacy Policy.

Children's Privacy

We do not knowingly collect information from children to sell or promote our products or services. We host educational programs in science for students and teachers in our communities, but we do not invite minors to contact us or manually provide personal information. Visitors must be 18 years of age or older to submit registration or survey information. Parents or legal guardians may register to obtain information or participate in a survey on behalf of their children. If you believe a child under the age of eighteen has sent personal contact information to Community Health Council of Wyandotte County, please contact us immediately at the address listed below and we will use reasonable efforts to promptly remove that information from our databases.

Security

We take commercially reasonable precautions to protect the confidentiality, integrity and security of your personal information. We urge users to be careful with personal information while using the Internet.

SSL Protection. Some password-protected areas of our website, require that a secure connection between your computer and our server be established. We use an encryption technology called Secure Socket Layers (SSL). A secure connection is maintained until you leave the secure area of the site. Although we use SSL encryption to safeguard the confidentiality of personal information as it travels over the Internet, "perfect security" does not exist on the Internet and we cannot guarantee the safety of transmitting personal information over the Internet.

Password Protection. You are responsible for maintaining the confidentiality of your passwords. We have the right to assume that anyone accessing one of our websites using a password assigned to you has the right to do so. You will be solely responsible for the activities of anyone accessing our website using a password assigned to you, even if the individual is not, in fact authorized by you. If you have reason to believe that your password has been compromised or used without authorization, you must promptly change it using the functionality provided on the site.
